This quote further throws light on the devaluation of the biological form, where even man's identity has been faded. Morgan painted a society where there is a kingdom of technology and science, and the identity Is fluid. As Tokashi Kovas the protagonist of the novel who has been hired as an investigator by Laurence Bancroft, a wealthy businessman to investigate the murder of Bancroft himself. This study aims to explore the meaning of identity in a transhumanist world where identity is not fixed, not same. It is a society where consciousness can be transferred from one body to another through the help of device called sleeves. It's a kind of cortical stacks which stores the memory of a person and later on it can shift to one person to another. This sleeves questions the existence of identity which shifts from one body to another. This research also questions the relation of mind and body and about the existence of man, where his identity is absurd and ambigious. This quote raises question about the purpose of living for a long time that Meths due to power and money are increasing the longevity of their lives but their memories which are keep on moving from one body to another is they are comfortable in their new forms or not? This is what happened in the novel that Lauren's bancroft have wealth and because of this power he hired an envoy from Mars to investigate his murder. This thing questions the meaning of real death, whether a man dies in a an advanced world or not? Bancroft multiple resleeving just faded the original self of him as from centuries his memory is switching from one body to another, here the question raises whether that body shifting is preserving their identity or it is just devaluing and decreases the beauty of their original self, where their own identity have become alien they are in someone's else body which actually dont have any connection to their real selfs. Moreover this study also throws light on the unjust attitudes of dehumanising the bodies by transfering them into cloned and rented sleeves. The body is decreases to the level of a mera vessel which challenges the traditional idea of physical identity." It's just a rental, Kovac. You can walk from it any time." (Morgan, 2002, p.91) These lines shows the worth of the rental or cloned bodies which is of no ssignificance. So Basically this study explores the meaning of identity in a transhumanist world, where the meaning of death has changed and there's a boundary between real and fake.

Analyse the impact of technology on human consciousness

Technology in the novel plays a vital role in reshaping the lives of the people, Morgan presented a society where the technology is having dominance over the lives of people and how it reshapes the identity of people. This research explores the concept of biological body and the digital body where the technology has snatched the meaning of real self. The consciousness and the memory of a person is no longer their own rather it is being attached to their body through the digital machine called cortical stacks a tiny device which has been attached with the skull of the body and then it can be transferred to any other bodies even the multiple ones. His identity has been distorted and it is hard to recognise their own physical form. Throughout the novel Kovac experienced different incidents which gives him a chance to think about his own self his own biological form. The protagonist moves from different scenarios which him a chance of self discovery as well. Another impact of technology on human consciousness is like a sense of victory for the the rich to defeat death in that mechanical land. Bancroft constant shining from one body to another gives him power to mock the actual death which cannot touch the Meths but on the otherhand it also throws light on the purpose of living for a long time." When you can live forever, what do u life for?" (Morgan, 2002, p. 247) These lines giving the realistic stance of living forever a meaningful activity which is of use. The longevity of living for a long time is only creating confusion and making the lives of these people complex where they are struggling hard to search their true bodies. Bancroft continously switching of bodies is



making him alienated from his own true identity. Another impact of technology on consciousness shift is the possibility of duplication when one consciousness exists in many different bodies as in one incident Bancroft's backup copy is revived which creates the confusion of existence of one consciousness in two fifteenth bodies. "If I was him, and he was me, which one of us was real?" (Morgan, 2002, p.312) this line shows a boundary between the real and fake and also states that technological advancement may cause fragmentation and may create complexity. This reaserch further sheds light on treating bodies as commodities, consciousness is no longer sacred rather it has become a commodity. So Altered Carbon presents a dystopian land which is having the dominance of technology and science on the lives of people, and because of these excessive technology the humanity is suffering it is making it hard for people to recognise their true identities and it also create chaos and leave deep impacts on human consciousness as well. So the aim of this study is to pinpoint the ideas that how and where this technology is influencing and also destroying the consciousness.

Investigate themes of immortality and its effects on identity.

Richard k Morgan portrays a future land where advanced technology can beat the death making people immortal. The purpose of this study is to tell the themes of immortality and how it is effecting the identity. There are some ultra elite people who make a duplicate copy of themselves trying to switch their body to their copy body which further makes it more complicated to identify the one's true self. "I saw myself staring back at me. Same face, same memories, but was it really me?" This novel also critiques on the unjust attitudes which is prevailing in the society. Because of this inequality the Rich people can achieve immortality in this mortal world. "A body

This research also shows the psychological burden of living for centuries as well. As Bancroft because of switching his body multiple times faces detachment from his own self. "I have lived so long that nothing matters anymore. Faves blurs, lives fade. Time becomes an endless loop" (Morgan,2002,p.312).
